#### **REGULATIONS ON ENTRY TO THAILAND & COE APPLICATION**

Non-Thai travellers are permitted to enter Thailand, <u>provided that</u> they have:

- Certificate of Entry (COE) issued by the Embassy
- Valid visa or re-entry permit, unless the traveller is qualified for visa exemption (for visa application process, please refer to http://thaiembassy.cz/download.php?id=26). Kindly note that the Royal Thai Embassy will accept visa application \*by appointment only\*.
- Health insurance policy (or "confirmation letter" issued by the insurance company) in English
  which expressly covers treatment and medical expenses in relation to COVID-19, with a
  minimum coverage of 100,000 USD for the whole period of stay in Thailand (except for
  diplomats and representatives of foreign governments or international organizations, where
  "Letter of Guarantee" is needed). Travellers are advised to purchase their health insurance
  which meets Thailand's entry criteria here: <a href="http://covid19.tgia.org/">http://covid19.tgia.org/</a>
- Medical Certificate with a laboratory result indicating that COVID-19 is not detected, using RT-PCR method, which has been certified or issued no more than 72 hours before departure.

### Hotel confirmation

Confirmation of fully paid Alternative Quarantine (AQ) hotel booking for a 14-days quarantine OR

Confirmation of fully paid SHA+ hotel reservation for no less than 14 days, together with evidence of pre-payment for required RT-PCR tests for travellers applying for "Phuket Sandbox" programme (terms and conditions apply) OR

Confirmation of fully paid Samui Extra+ & SHA+ hotel reservation for no less than 14 days, together with evidence of pre-payment for required RT-PCR tests for travellers applying for "Samui Plus" programme (terms and conditions apply)

Travellers under "Phuket Sandbox" and "Samui Plus" programmes must present an
additional document: Certification of Vaccination, in English (or with English translation)
issued by a government authority, containing personal information of the travellers (name,
date of birth, passport number) and information on the vaccine (name, batch number,
vaccination dates) (if applicable).

All travellers who have received COEs are required to download, and register via, ThailandPlus Application. They are required to show a QR code generated from the registration via the Application to be scanned by Thai authority upon arrival in Thailand (https://thailandplus.in.th/en/).

<sup>\*\*</sup> Travellers should avoid crowded or high-risk places at least 14 days before travelling to Thailand and they must wear masks while travelling.\*\*

# SAMUI PLUS PROGRAMME

## 1. What is Samui Plus programme?

• Similar to Phuket Sandbox, Samui Plus is a tourism-promotion scheme that allows fully vaccinated travellers to enter Koh Samui, Thailand, without quarantine, subject to conditions below.

## 2. Eligible travellers

- Must be fully vaccinated against COVID-19 with a vaccine registered with the Food and Drug Administration of Thailand (FDA), or approved by World Health Organization (WHO) or Ministry of Public Health of Thailand no less than 14 days before departure. Travellers must show Certificate of Vaccination issued by a government authority, e.g. EU Digital COVID Certificate. The certificate in English (or with English translation) must contain personal information of the travellers (name, date of birth, passport number) and information on the vaccine (name, batch number, vaccination dates), if applicable.
- Children under the age of 18, travelling with parents, are eligible without proof of vaccination.
- Must come from countries/areas allowed to enter Samui Plus. At present, travellers from the Czech Republic are eligible. Travellers must, however, be in these eligible countries for at least 21 consecutive days.
- Must have health insurance which covers treatment and medical expenses in relation to COVID-19, with a minimum coverage of 100,000 USD for the whole period of stay in Thailand. Travellers are advised to purchase their health insurance which meets Thailand's entry criteria here: http://covid19.tgia.org/
- Both non-Thais and Thais are eligible.

## 3. Conditions

### **Travelling to Koh Samui**

- Traveller must enter Koh Samui with a direct international flight (arriving at Samui International Airport from another country) <u>OR</u> with an international flight that enters Thailand via Suvarnabhumi International Airport (Bangkok) and is connected to Koh Samui through approved sealed flights, route BKK-USM: Flight No. PG5125/PG5151 or PG5174.
- For flights to Koh Samui via Bangkok, the ticket must be issued on the same booking with international flight in conjunction with such approved Bangkok-Samui flights. Any flight reservations booked separately will not be accepted.
- Travellers should contact their airlines directly to <u>ensure that the route origin-Bangkok-Samui is booked together in a single booking and that their luggage is checked-through to Koh Samui.</u>

#### Hotels

- <u>Days 1–7</u>: stay at hotel certified as "**Samui Extra+"**. List of Samui Extra+ facilities is attached at the end of this document (pls. contact the hotel directly).
- <u>Days 8–14</u>: stay at hotel certified as "**SHA+**" in **Koh Samui**. For a list of SHA+ facilities, visit https://www.thailandsha.com or https://www.shathailand.com
- Confirmation of "SHA+" hotel booking must be issued under the SHABA system (SHA Plus Booking Authentication system). Please contact your hotel directly to ask for the SHABA Certificate. Booking confirmation through agents will not be accepted.
- Confirmation of pre-paid accommodation at Samui Extra+ and SHA+ is needed for a total of 14 days, unless travellers have proof of return tickets leaving Koh Samui (to another country) before 14 days.

## **COVID-19 tests**

- Travellers must present RT-PCR negative test result issued no more than 72 hours before departure.
- Upon entry, travellers will have to undergo three COVID-19 tests at different times, at the
  traveller's own expenses. The first test will be done upon arrival; travellers will be allowed
  outside of their hotel rooms only upon confirmation of negative result of the first test.
  The second test will be carried out on 6th or 7th day, and the third test on 12th or 13th
  day.
- Children under the age of 6 are allowed to undergo saliva-sampled test.
- To apply for COE, travellers must submit evidence of pre-payment for the required RT-PCR tests (please contact the hotel directly to inquire).

## Permitted movements within Koh Samui & nearby islands

- <u>Days 1-3 (hotel-based)</u>: upon receiving negative result of the <u>first</u> RT-PCR test, travellers may leave their hotel room **but are required to stay within the premises of the hotel**.
- <u>Days 4-7 (sealed route)</u>: travellers are allowed to travel within **specified routes/travel programme** on Koh Samui. Travellers must undergo second RT-PCR test on 6th or 7th day.
- <u>Days 8-14 (relaxed)</u>: upon receiving negative result of the <u>second</u> RT-PCR test, **travellers** may travel within Koh Samui, Koh Phangan and Koh Tao.

## Journey-tracing application

- Travellers must install and use journey-tracing application (turn on GPS) as prescribed by the Thai Government.
- Upon leaving Koh Samui to other parts of Thailand after 14 days, travellers must provide proof of 14 days of stay in Koh Samui/Koh Phangan/Koh Tao and three RT-PCR test results.

# 4. How to apply for COE

- Travellers under "Samui Plus" programme must apply for a Certificate of Entry (COE), like all other travellers, via https://coethailand.mfa.go.th/
- Please choose option "Sandbox Programme", and then select "Samui" as Sandbox destination when completing the "travel details" column.

## REQUIRED DOCUMENTS FOR COE APPLICATION:

Before registration the applicant should prepare files of required documents in .pdf or .jpeg version to upload to the system.

Documents for pre-approval stage (Registration):

- Copy of passport
- Copy of longterm or permanent residence in the Czech Republic (non-Czech nationals)
- Health insurance which expressly covers treatment and medical expenses in relation to COVID-19, with a minimum coverage of 100,000 USD for the whole period of stay in Thailand. In English or Thai language. Travellers are advised to purchase their health insurance which meets Thailand's entry criteria here: http://covid19.tgia.org/
- Certificate of Vaccination, in English (or with English translation) issued by a government authority, e.g. EU Digital COVID Certificate. The certificate must contain personal information of the travellers (name, date of birth, passport number) and information on the vaccine (name, batch number, vaccination dates).

Documents for final approval stage (Confirmation):

- Ticket to and out of Thailand https://bit.ly/2Ude2kx
- Confirmation of fully paid "Samui Extra+" and "SHA+" hotel booking. SHA+ hotel booking must be issued under the SHABA system (SHA Plus Booking Authentication system). The Confirmation must also contain information on arranged and paid three Covid-19 tests by RT-PCR method in the following periods:
  - 1st time on the date of arrival in Koh Samui
  - o 2nd time on day 6th-7th
  - o 3rd time on day 12th-13th
