

# Single Entry TOURIST VISA

**!!! VISA APPLICATION SHALL BE SUBMITTED AT LEAST  
2 WEEKS BEFORE TRAVEL !!!**

## REQUIREMENTS

This type of visa is issued to applicants who wish to enter Thailand for tourism purposes for more than 30 days. **(The Czech nationals can enter Thailand for tourism purposes for maximum 30 days without visa requirement.)**

**VISA APPLICATION OF EACH PERSON (inc. children) MUST CONTAIN THE FOLLOWING SET OF DOCUMENTS:**

- **Passport** / travel document with validity at least 6 months from the intended date of arrival to Thailand.
- **Copy of passport** / travel document data page.
- **Copy of longterm or permanent residence in the Czech Republic** (non-Czech nationals).
- **Visa application form** completely filled.
- **1 passport size photograph** of the applicant, taken within the past six months.
- **Copy of return ticket or ticket reservation** (to and out of Thailand). In English language.
- **Copy of hotel/accomodation reservation** for at least half of the stay in Thailand (name of applicant must be shown). In English or Thai language.
- **Original bank statement or confirmation from the bank**, issuing within one month, showing actual balance of minimum 15,000CZK/person or 30,000CZK/family. In case of STUDENTS, RETIRED, UNEMPLOYED and SELF-EMPLOYED PERSONS: original bank statement or confirmation from the bank showing actual balance of minimum 30,000CZK/person. If submitting printed copy from internet banking, name, actual balance and date of printing must be shown.  
The bank documents showing actual balance must be in English or with official translation to English.

## **VISA FEE**

850 CZK

- Visa fee (exact amount) shall be paid in cash when submitting visa application.
- Visa fee is not refundable.
- Visa fee may be changed without prior notice.

**Consular officer reserves the right to request additional documents, or an interview with the applicant, as deemed necessary, without prior notice.**

**The Royal Thai Embassy reserves the right to reject any visa application with insufficient documents or if the reasons given are not fully supported.**

## **VISA PROCEDURE**

**Visa application shall be submitted at least 2 weeks prior to the departure to Thailand!**

Visa application (required documents and visa fee) shall be submitted every working day between 9 to 12 hrs. at the Embassy: Romaina Rollanda 3, Prague 6.

**The Embassy does not accept visa application via mail or online!**

If the Embassy does not require any additional documents or information, the visa procedure may take 4 working days.

**The Embassy does not provide express visa service!**

## **VISA VALIDITY AND PERIOD OF STAY**

Single-Entry Tourist Visa is valid for entering Thailand once within 3 months from the date of issuance.

The period of stay is up to 60 days. Period of stay is granted by an immigration officer upon arrival to Thailand.

## **EXTENSION OF STAY**

Those who wish to stay longer or may wish to change their type of visa must file an application for permission at the Office of Immigration Bureau located on Government

Center B, Chaengwattana Soi 7, Laksi, Bangkok 10210, Tel 0-2141-9889 (more information can be found at <http://www.immigration.go.th>). The extension of stay as well as the change of certain type of visa is solely at the discretion of the immigration officer.
