

## **MEDICAL TREATMENT (non-immigrant visa, category O)**

Non-Thai nationals who need to receive medical treatment in Thailand, including their accompanying persons, except for treatment for COVID-19, wishing to apply for visa shall apply **in person** at the Embassy after making the appointment at: [visa@thaiembassy.cz](mailto:visa@thaiembassy.cz), **at least 20 working days (4 weeks) prior to the departure.**

Documents for non-immigrant visa, category O, single entry only:

- **Passport** with validity at least 6 months from arrival to Thailand
- **Copy of passport**
- **Copy of longterm or permanent residence in the Czech Republic** (non-Czech nationals)
- **Visa application form** completely filled and signed
- **1 recent passport size photograph**, taken within the past six months
- **Ticket to and out of Thailand** or ticket reservation\_
- **Financial statement** showing that the applicant is able to take responsibility for all of the treatment expenses and any other expenses that may be incurred during the stay in Thailand.
- **Copy of bank statement** – in English or Thai language.
- **Copy of confirmation letter for Alternative Hospital Quarantine (DHSS/AHQ 1) with stamp of approval from Ministry of Public Health.**
- **Visa fee: 1600 CZK** (paid in cash)

**Once the visa is issued travellers must register for Thailand Pass at [tp.consular.go.th](https://tp.consular.go.th) at least 7 days prior to departure. Without the Thailand Pass QR Code, they will be refused entry to Thailand.**

## **ACCOMPANYING PERSONS (non-immigrant visa, category O)**

Non-Thai nationals who need to receive medical treatment in Thailand, including their accompanying persons (maximum 3 persons), except for treatment for COVID-19, wishing to apply for visa shall apply **in person** at the Embassy after making the appointment at: [visa@thaiembassy.cz](mailto:visa@thaiembassy.cz), **at least 20 working days (4 weeks) prior to the departure.**

Documents for non-immigrant visa, category O, single entry only:

- **Passport** with validity at least 6 months from arrival to Thailand
- **Copy of passport**
- **Copy of longterm or permanent residence in the Czech Republic** (non-Czech nationals)
- **Copy of passport of patient**
- **Visa application form** completely filled and signed
- **1 recent passport size photograph**, taken within the past six months
- **Ticket to and out of Thailand** or ticket reservation\_
- **Financial statement** showing that the patient is able to take responsibility for all of the treatment expenses and any other expenses that may be incurred during the stay in Thailand.
- **Copy of patient's bank statement** – in English or Thai language.
- **Patient's copy of confirmation letter for Alternative Hospital Quarantine (DHSS/AHQ 1) with stamp of approval from Ministry of Public Health.**
- **Affidavit of Support with stamp of approval from Ministry of Public Health (DHSS/AHQ 2)**
- **Proof of accommodation in Thailand** for the whole period of stay in Thailand (after completing the Alternative Hospital Quarantine)
- **Visa fee: 1600 CZK** (paid in cash)

**Once the visa is issued travellers must register for Thailand Pass at [tp.consular.go.th](http://tp.consular.go.th) at least 7 days prior to departure. Without the Thailand Pass QR Code, they will be refused entry to Thailand.**
