

Multiple-Entry TOURIST VISA

**!!! VISA APPLICATION SHALL BE SUBMITTED AT LEAST
2 WEEKS BEFORE TRAVEL !!!**

REQUIREMENTS

This type of visa may be granted to short term visitors who intend to travel to Thailand for tourism purposes up to 60 days per trip. **(The Czech nationals can enter Thailand for tourism purposes for maximum 30 days without visa requirement.)**

DOCUMENTS REQUIRED

- **Passport** / travel document with validity at least 6 months from the intended date of arrival to Thailand.
- **Copy of passport** / travel document data page.
- **Copy of longterm or permanent residence in the Czech Republic** (in case of foreigners).
- **Visa application form** completely filled.
- **1 passport size photograph** of the applicant, taken within the past six months.
- **Copy of return ticket** (to and out of Thailand) in English language. At least for the first visit.
- **Copy of hotel reservation** or other evidence of accommodation reservation in Thailand. At least for the first visit. In English or Thai language.
- **Copy of a bank statement or confirmation from the bank** with a minimum balance of 160,000 CZK per person or 320,000 CZK per family for the last 6 months from the account of each applicant. The bank documents must be in English or with official translation to English.
- **Letter from applicant's Employer verifying his/her employment** (in English language) and signed copy of ID card or passport of the signatory. Or extract from Company's Register with official translation into English in case of self-employed persons. Or confirmation from school in English in case of students.

VISA FEE 4,000 CZK

- Visa fee (exact amount) shall be paid in cash when submitting visa application.
- Visa fee is not refundable.
- Visa fee may be changed without prior notice.

Consular officer reserves the right to request additional documents, or an interview with the applicant, as deemed necessary, without prior notice.

The Royal Thai Embassy reserves the right to reject any visa application with insufficient documents or if the reasons given are not fully supported.

VISA PROCEDURE

Visa application shall be submitted at least 2 weeks prior to the departure to Thailand!

Visa application (required documents and visa fee) shall be submitted every working day between 9 to 12 hrs. at the Embassy: Romaina Rollanda 3, Prague 6.

The Embassy does not accept visa application via mail or online!

If the Embassy does not require any additional documents or information, the visa procedure may take 4 working days.

The Embassy does not provide express visa service!

VISA VALIDITY AND PERIOD OF STAY

Multiple-Entry Tourist Visa is valid for entering Thailand within 6 months from the date of issuance. The holder may enter Thailand again as long as the visa is still valid.

The period of stay is up to 60 days per trip. Period of stay is granted by an immigration officer upon arrival to Thailand.

EXTENSION OF STAY

Those who wish to stay longer or may wish to change their type of visa must file an application for permission at the Office of Immigration Bureau located on Government Center B, Chaengwattana Soi 7, Laksi, Bangkok 10210, Tel 0-2141-9889 (more information can be found at <http://www.immigration.go.th>). The extension of stay as well as the change of certain type of visa is solely at the discretion of the immigration officer.
